## Summary Report

The goal of this research project was to identify the biological parents of [CLIENT], the father of your late husband, Harold Daniel Stillwell. For this project, we were to include limited biographical material as it was uncovered and to only include siblings, spouses, or others when necessary for extending ancestral lines.

We have made significant progress on this research project and identified a promising candidate to be your husband's biological paternal grandmother. Her name is [CLIENT]. Several of her known grandchildren are still living and may be good resources as you try to piece together [CLIENT]story.

We identified [CLIENT]through DNA evidence, but you may recall the surname Glassford appeared in a 1934 letter from William E. Stillwell to Mrs. Feldman Stillwell that you provided. This was a very helpful clue as we reviewed DNA matches and began seeing that name.

#### **Background**

[CLIENT] was believed to have been born on 22 November 1905 in Ohio. You described and provided evidence of his tendency to avoid discussing his past and to provide different locations for his birthplace. [CLIENT] was reportedly adopted by William E. Stillwell and Flora Ella (or Ellen) Berry at about 6 weeks old. In his 1934 letter to Carl's wife, Pauline,

William stated they adopted [CLIENT] at 6 weeks old, that his grandmother and grandfather signed the papers, and that he thought their surname was Glassford.

#### **Summary**

DNA analysis of your husband's DNA results led us to the Glassford family, consistent with [CLIENT] adopted father's statement about the surname Glassford. William Glassford and [CLIENT] of Ohio had four children who lived to adulthood: Mabel (born 1870), Howard (born 1872), Carrie (born 1876), and Katherine "Katie" (born 1882). The Glassford family lived in Warren County, which includes the Cincinnati area, from the 1870s through at least 1900, but had relocated to neighboring Montgomery County, which includes the Dayton area, by 1910.

Mabel married in 1893 and had one son in 1894. Carrie married in 1902 and had the first of her three children in 1903. It seems unlikely that either woman would give a child up for adoption after they had married and started their respective families.


A marriage record has not been located for Katie, but her 1910 U.S. Census entry indicates she had been married for five years to George D. Freeze. Their first child was born in March of 1906. This initially seemed to be a conflict because she could not give a 6-week-old child up for adoption in November of 1905 and then give birth four months later. Carl's Social Security Death Index entry gave a birth date of 21 November 1903. This seemed unusual because all other records gave his birth date as 22 November, although they differed on the year, ranging from 1902 to 1905. We requested his application for a Social Security number, form SS-5, which unexpectedly did not agree with the Social Security Death Index.

We closely reviewed each record providing direct or indirect evidence of Carl's birth year.

Conventional genealogical wisdom gives greater weight to records created closest to one's birth. Therefore, the 1910 census, which suggests Carl was born in 1903, is likely closer to the truth. Dates recorded later are more subject to be in error or intentionally misleading. It is not clear why his SS-5 would show 1904 while the Social Security Death Index reports 1903 or why there are discrepancies in the California Death Index entry. However, these documents collectively create sufficient doubt in the November 1905 birth date self-reported on two later censuses and his World War II draft card. Importantly, if Carl was born prior to 1905—whether it was 1902, 1903, or 1904—it eliminates the pregnancy conflict. Both of Katherine's sisters had married by mid-1902, leaving her as the only unmarried Glassford daughter at the time.

DNA data also supports the conclusion that Katherine Glassford likely was Carl Stillwell's biological mother. Four DNA matches who are Katherine's great-grandchildren each share more DNA with Dan than Dan shares with a great-granddaughter of her sister Carrie Glassford. The diagram below shows the probable relationships between Dan and his cousins.



#### **Recommendations**

As you consider our finding of Katherine Glassford as Carl's biological mother, we recommend the following actions be taken:

- 1. Reach out to Angela Scurini, Daniel MacMurchy, Justeen Hammett, and James Metcalf—as well as their living parents—to learn more about Katherine Glassford. For advice regarding reaching out to newly discovered family, we recommend the resources listed in https://legacytree.com/blog/resources. The article is aimed at those with surprise DNA results; however, it includes suggestions and scripts for making contact with any previously unknown biological family.
- 2. Invite Jean (Freeze) Metcalf to perform a DNA test. As the mother of Dan's strongest match in the Freeze family, her DNA could help confirm or refute the proposed relationship.
- 3. Invite either Barbara (Shaw) Smith or Marjorie (Shaw) Borom to perform DNA testing. This could also help confirm or refute the proposed relationship.
- 4. Order the California death record for "Charles D. Stillwell," who died 8 January 1984 in San Mateo County.

- 5. Encourage one of your children to request Carl's adoption file from the state of Ohio (application attached). For information, see https://odh.ohio.gov/wps/portal/gov/odh/know-our-programs/vital-statistics/adoption-file-information.
- 6. Explore the identity of Carl Willard Dudley Stillwell's father using the remaining matches who do not match the Glassford-Freeze family.
- 7. We recommend researching the Bishop family living close to Sarah Glassford in 1910. Two possible Bishop sons were boarding with Glassford family members in 1900 that could be potential paternal candidates.

This has been a fascinating case to untangle. We look forward to working with you again in the future to explore these ancestral lines further and identify Carl's biological father.

### Research Analysis

#### **GOALS**

- Using DNA analysis and traditional genealogy research, identify the biological parents of Carl Willard Dudley Stillwell. Carl was born on 22 November 1905 in it is believed to be Ohio and was the spouse of Pauline Feldman.
- Once the parents are identified, research all lines of Carl Stillwell's ancestry.

| AUTOSOMAL DNA OVERVIEW  |  |  |

Each individual inherits half of their autosomal DNA from each of their parents. Beyond that, the

amount of DNA shared in common is only approximate due to a random process called recombination which shuffles the DNA each generation. Each individual will inherit about 25 percent from each grandparent, 12.5 percent from each great-grandparent, and approximately half the previous amount for each subsequent generation. Eventually, there will be some ancestors in a person's family history from whom they have inherited no DNA. Although two first cousins will have both inherited 25 percent of their DNA from each of their common grandparents (50 percent in total), they will have inherited a different 25 percent. Therefore, first cousins will typically only share about 12.5 percent of their DNA in common.

Centimorgans (cM) are a unit of measurement commonly used in genetics to measure genetic recombination and express the likelihood that two locations on a DNA strand are inherited together. Larger segments with high centimorgan values typically suggest two individuals share a recent common ancestor.







Katie's first son was born in March 1906. According to the provided information, Carl Willard Dudley Stillwell was born 22 November 1905. This would make it impossible for Katie to be Carl's biological mother. However, several birth date discrepancies were noted. They are discussed in the next section.



Using a third-party tool which analyzes possible relationships among people based on the amount of DNA they share, we confirmed Katie Glassford is statistically far more likely than either of her sisters to have been Carl's mother.

The table below shows the "What Are the Odds?" analysis using Dan's closest cousins who descend from William Glassford and Sarah Hunter. A higher score for a hypothesis means that option is more likely. Hypothesis 1, with Mabel as the mother scored 2, Hypothesis 2 with Carrie as the mother scored 1, and Hypothesis 3 with Katie as the mother scored 2. This analysis supports the conclusion Katherine "Katie" Glassford is the most probable candidate for Carl Willard Dudley Stillwell's biological mother
